FROM THE EXECUTIVE DIRECTOR AND PRESIDENT OF THE BOARD

In fiscal year 2024, the Heart of the Civil War Heritage Area (HCWHA) stepped assertively into the first goal of our strategic plan, to "embrace creative risk-taking...." The goal's intent is to encourage enhanced product development among our partners, and we choose to lead by example.

We expanded and enhanced our team, welcoming Olivia Peterson as our Heritage Area Assistant and promoting Emily Huebner to the role of Director of Operations and Programs. Our Board of Directors recognized these steps as necessary to meet increasing demand for heritage area services. Throughout this report it will be clear that deepening our capacity extends our impact in Carroll, Frederick, and Washington counties.

In November 2023, the largest and most diverse audience for our annual Year-in-Review turned out to hear best-selling author Clint Smith and participate in a fireside chat-style conversation moderated by Chris Haley, Maryland State Archives Director of the Study of the Legacy of Slavery in Maryland.

Strides were made, guided by our Finance Committee, to create new paths for individuals, businesses, and others to contribute to the sustainability of the heritage area. New long-term investment vehicles include the Legacy Leaders Circle (planned giving) and the HCWHA Agency Fund with the Community Foundation of Washington County. An additional allocation of Maryland Community Investment Tax Credits created more advantage for annual fund supporters.

As always, we encourage you to explore the powerful places of our three-county area. In doing so, you help bring our vision closer to reality: "A vast and diverse audience engages meaningfully with the past and present in the HCWHA, carrying their experiences here into the future."

MARYLAND HERITAGE AREAS AUTHORITY (MHAA) **PROJECT GRANTS**

MHAA grants are only available to those located within the boundary of a certified heritage area. Projects advance heritage tourism and grant awards must be matched by the applicant with non-State funds to increase public-private investment. HCWHA staff coaches local applicants and provides technical support; the HCWHA Board, Advisory Council, and expert volunteers review local applications before they move on for MHAA consideration. A Maryland grant review panel determines final grant awards across the state.

HCWHA staff works closely with local applicants to the MHAA grant program, but the relationship and assistance goes beyond the financial benefit of being located within a Heritage Area.

HCWHA is frequently consulted to provide advice and guidance regarding collections, strategic planning, nonprofit administration and Board management, historic preservation resources, sources of funding beyond MHAA, and many other unquantifiable aspects of maintaining our vibrant heritage tourism ecosystem.

HCWHA VISITOR CENTER AT THE NEWCOMER HOUSE

The Historic Newcomer House on the Antietam National Battlefield has served as the Heritage Area's Visitor and Exhibit Center since 2010. It is often the first stop for battlefield visitors, and they are met by **one of our approximately 40 dedicated volunteers**.

Newcomer House docents come to us from many walks of life, **each bringing their own special personality** to the interpretive opportunities at Newcomer House, and they are truly the heartbeat of our "home."

GEOTOUR

HCWHA has been awarded funding from Visit Frederick's TRIPP grant program and the Rural Maryland Council to lead the creation of a GeoTour to guide visitors through 250 years of history, taking them to Geocaches at historic sites, Main Streets, and more. This project builds on the success of the nearly decade-old HCWHA GeoTrail, which was traveled by 2,000 accounts, representing participants from 45 states and 13 countries.

Biannual 250th gatherings have continued in fiscal year 2024, bringing history organizations, local governments, and others together across all three counties to share progress, resources, and funding sources.



Fiscal year 2024 marked two years of progress on a six year plan. HCWHA has been advancing all goals and objectives identified within four strategic areas: Product Development, Building Partnerships, Regional Identity, and Organizational Development.





HIGHLIGHTS INCLUDE:



GOAL: Ensure that experiences in the Heritage Area are appealing and welcoming to diverse audiences that reflect future visitation trends.

Developed a Spanish-language landing page on our website, hcwha.org, to pair with a Spanish-language radio advertisement. Crossroads of War website update project highlights new research on African American history in the region.



GOAL: Support and coordinate the commemoration of the 250th anniversary of the United States across the Heritage Area.

Regular 250th anniversary convenings to gather partners from all three counties in a unique opportunity to discuss progress and share resources.



GOAL: Support capacity building through technical assistance for heritage and cultural tourism organizations in the Heritage Area.

HCWHA hosted simultaneous sessions in all three counties to explore the possibility of implementing a Standards for Excellence Program (American Association for State and Local History-AASLH-curriculum) cohort, collecting feedback and sharing the program with stakeholders. Participated in local strategic planning efforts, introduced partners to resources to preserve and develop heritage tourism products.



GOAL: Develop and implement a plan for sustainability for the Heritage Area.

Establishment of the Legacy Leaders Circle. This circle of donors include HCWHA in their estate planning. Secured an additional \$10,000 of Community Investment Tax Credits to award to eligible donors. Created an Agency Fund with the Community Foundation of Washington County.



GOAL: Align the human resources of the Heritage Area with its future needs.

The addition of a Heritage Area Assistant to HCWHA staff increased the organization's capacity, allowing staff to devote additional time to the core mission: working together with our fellow nonprofits and government units to preserve and promote our region's unique history.



GOAL: Facilitate/support platforms and methods to connect and weave assets of Heritage Area together into cohesive experiences and products.

Began the redesign of the HCWHA website and brochure, to be completed in fiscal year 2025. Pursuing the creation of a three-county GeoTour to commemorate the US 250th anniversary.

Projects in the HCWHA broke new ground with new ways of visualizing buildings that have long disappeared from the landscape with digital and ingenious physical recreations, a mobile app integration to the experience of a historic cemetery, bilingual signage, and collaborative community storytelling through theatre.


